Bill Marohn's Report to the School Board

At the January 4, 2016 Board of Education meeting, Foundation President, Bill Marohn, reported that the Foundation raised \$347,111.80 in unrestricted funds and \$64,000 in restricted funds, for a total of \$402,611.80, far surpassing its 2015 goal.

As a result, the Foundation was able to fund projects totaling \$356,000 which benefited the students and teachers in

the district. Major projects funded were 1:1 Computing (\$100,000), 300 Chromebooks (\$60,000), 9 scholarships (\$45,000) and Professional Learning Communities at Work (\$41,206).
